

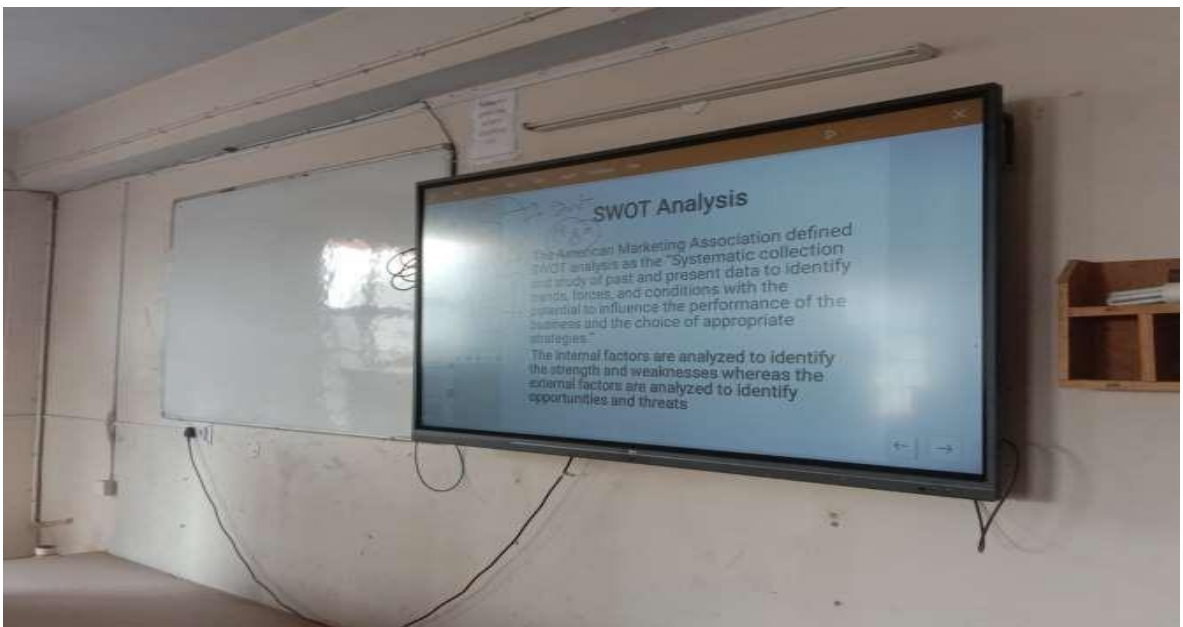
## 1. ICT Facilities:

The college is equipped with advanced ICT facilities, enhancing the learning experience with 30 classrooms, labs, and seminar halls integrated with Information and Communication Technology (ICT). Out of a total of 50 rooms, 60% are equipped with projectors, interactive panels, digital podiums, and Wi-Fi or LAN connectivity.
